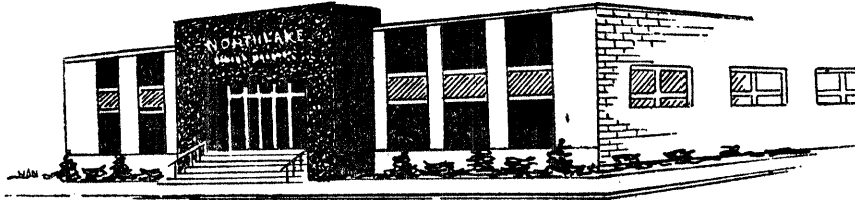

AN ORDINANCE ANNEXING CERTAIN CONTIGUOUS
TERRITORY TO THE CITY OF NORTHLAKE, ILL.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
NORTHLAKE, COOK COUNTY, ILLINOIS; that:

SECTION 1. That the following described territory adjoining
and contiguous to the limits and boundaries of the City of
Northlake, all of which territory is located in the County
of Cook, State of Illinois, is hereby annexed, added to,
taken into and made a part of the City of Northlake:

That part of the Northwest Quarter of the Southeast
Quarter of Section 30, Township 40 North, Range 12 East
of the Third Principal Meridian, bounded and described
as follows: Beginning at a point on the South line
of the said Northwest Quarter of the Southeast Quarter,
said point being 220.0 feet West of the Southeast corner
thereof; thence West along said South line a distance
of 967.90 feet to a point which is 133 feet East of the
West line of said Northwest Quarter of the Southeast
Quarter; thence North along a line which is 133 feet
East of and parallel with the West line of said
Northwest Quarter of the Southeast Quarter, a distance
of 100 feet; thence Northeasterly along a diagonal line
to a point on a line which is 220 feet West of and
parallel with the East line of said Northwest Quarter
of the Southeast Quarter, said point being 500 feet
North of the point of beginning; thence South along
said parallel line to the point of beginning.

Section 2. That the said territory hereinabove described
is assigned, made and classified to allow erection,
construction and maintenance of multiple dwelling residences
known as multiple dwelling residence special use in accordance
with the findings and recommendations of the Board of
Zoning Appeals.

Section 3. That the construction of commercial business
structures is hereby specifically excluded in the above
described territory.

Section 4. That the City Clerk is hereby directed to cause
a copy of this ordinance together with an accurate map of
the annexed territory to be recorded with the Recorder of
Deeds of Cook County, Illinois;

Section 5. That this ordinance shall be in full force and
effect from and after its passage and approval as provided
by law.

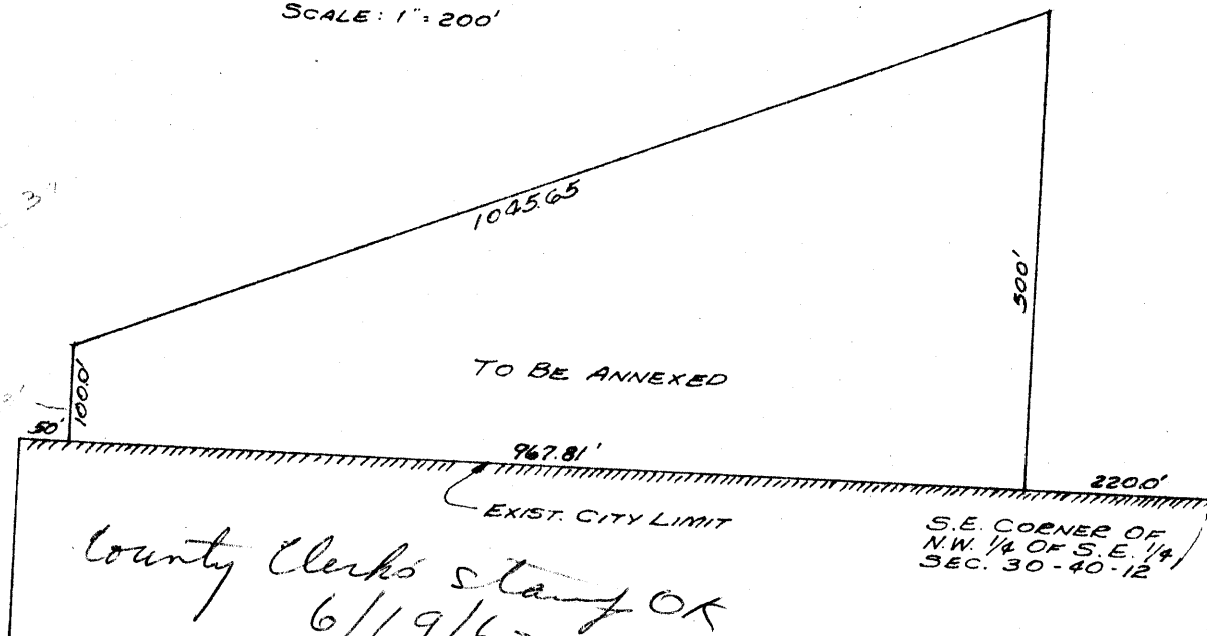
PLAT OF ANNEXATION
TO THE
CITY OF NORTHLAKE
OF

THAT PART OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 30, TOWNSHIP 40 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, BOUNDED AND DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE SOUTH LINE OF THE SAID NORTHWEST QUARTER OF THE SOUTHEAST QUARTER, SAID POINT BEING 220.0 FEET WEST OF THE SOUTHEAST CORNER THEREOF; THENCE WEST ALONG SAID SOUTH LINE A DISTANCE OF 967.81 FEET TO A POINT WHICH IS 133 FEET EAST OF THE WEST LINE OF SAID NORTHWEST QUARTER OF THE SOUTHEAST QUARTER; THENCE NORTH ALONG A LINE WHICH IS 133 FEET EAST OF AND PARALLEL WITH THE WEST LINE OF SAID NORTHWEST QUARTER OF THE SOUTHEAST QUARTER, A DISTANCE OF 100 FEET; THENCE NORTHEASTERLY ALONG A DIAGONAL LINE TO A POINT ON A LINE WHICH IS 220 FEET WEST OF AND PARALLEL WITH THE EAST LINE OF SAID NORTHWEST QUARTER OF THE SOUTHEAST QUARTER, SAID POINT BEING 500 FEET NORTH OF THE POINT OF BEGINNING; THENCE SOUTH ALONG SAID PARALLEL LINE TO THE POINT OF BEGINNING.
