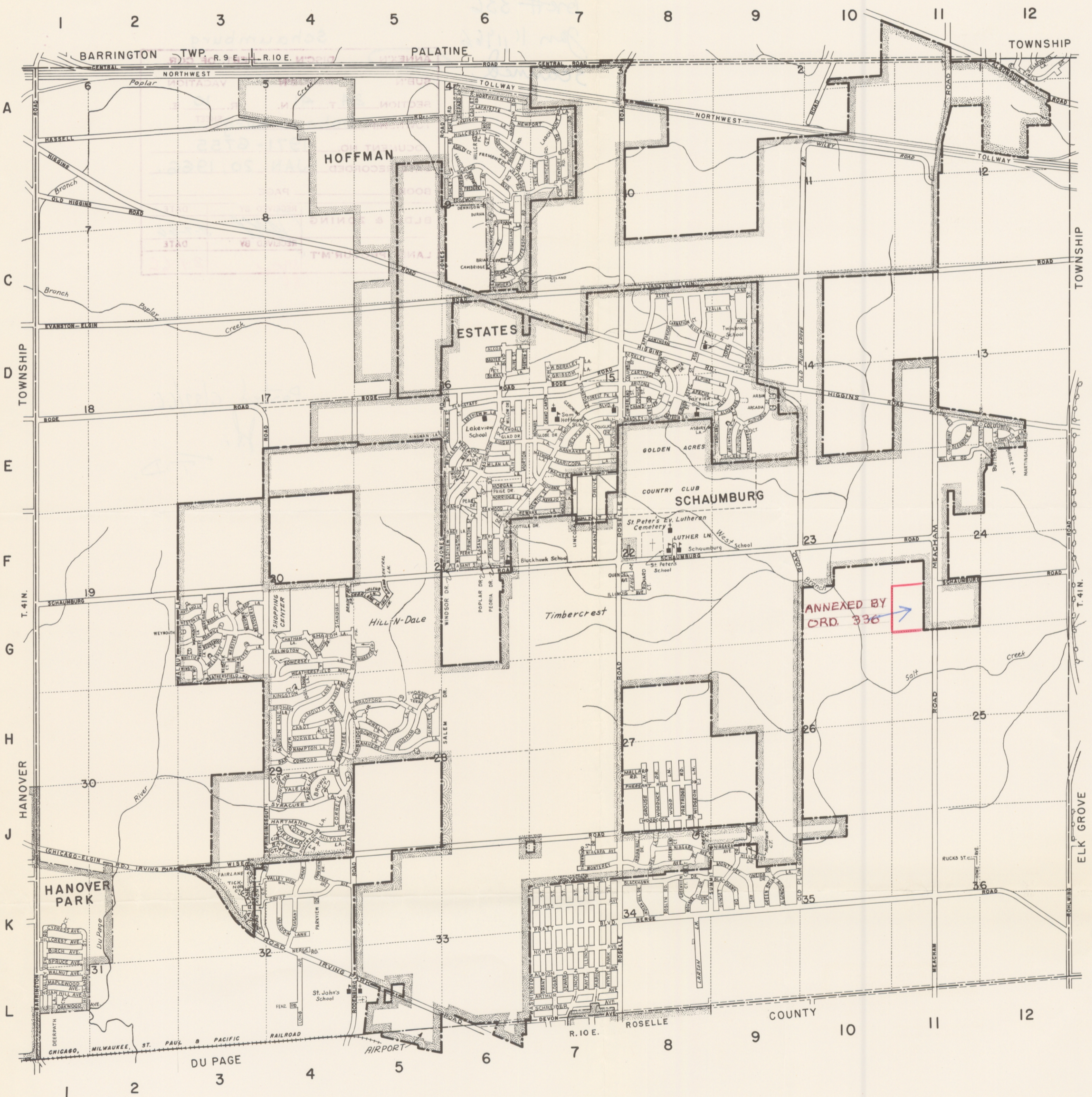


VILLAGE OF SCHAUMBURG, ILLINOIS

ORDINANCE NO. 336

AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE VILLAGE OF SCHAUMBURG

WHEREAS, a written petition under oath signed by the owners of record and electors of the territory hereinafter described has heretofore been filed with the Village Clerk of the Village of Schaumburg; and

WHEREAS, said territory is not within the corporate limits of any municipality but is contiguous to the Village of Schaumburg; and

WHEREAS, the corporate authorities of the Village of Schaumburg have determined that the annexation of said territory to the Village of Schaumburg is in the best interests of the Village of Schaumburg;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SCHAUMBURG:

SECTION ONE: That the territory legally described as:

The West 3/4 of the Southwest 1/4 of the Southwest 1/4 of Section 24, Township 41 North, Range 10, East of the Third Principal Meridian, in Cook County, Illinois,

an accurate map of which territory is attached hereto and made part hereof, be and the same is hereby annexed to the Village of Schaumburg.

SECTION TWO: The Village Clerk of the Village of Schaumburg is hereby directed to file in the office of the Recorder of Deeds of Cook County, Illinois, a copy of this ordinance, together with an accurate map of the territory annexed.

SECTION THREE: This ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
